SCHOLARSHIP PROGRAM

PrimeWay Federal Credit Union

Rules:

- FÈ Applicant must be a resident of Harris, Fort Bend or Washington County.
- GÈ Applicant must be enrolled at an accredited college/university or vocational/trade school for the fall 2019 semester.
- HÈ Applicants must complete the required enclosed application to apply for a Úiã ^Y æ Federal Credit UnionÁ scholarship. **(See attached application)**
- I È Applicant's GPA (Grade-point average) must be 3.0 or above (on a 4.0 grade scale). Acceptable documentationÁ includes official high school transcript or official college transcript with official seal.
- Í È A Letter of Recommendation/Reference must be submitted on school letterhead and signed by the appropriateÁ teacher, professor or school official.
- Î È Applicant must submit a typed 1000 words or less essay on the topic assigned in the application **(See Section VI)**.
- Ï È Applicant must submit a Letter of Acceptance or Registration from intended college/university or vocational/tradeÁ school on appropriate letterhead. If the student is already attending college then proof of enrollment is necessary. If this is not available before the application deadline, it will need to be providedÁ before the distribution of any scholarship funds.
- Ì È Applicant must thoroughly read and sign the Application Agreement. **(See Section VII)**
- JÈ The following documents are required for a completed scholarship application:
 1. Scholarship Application
 2. Official transcript(s)
 3. (1) One signed letter of recommendation on school letterhead
 4. 1000 word typed essay
 5. Confirmation of college acceptance/registration or proof of enrollment. (If document is not available by deadline, it must be provided before the distribution of any scholarship funds)
 6. Scholarship application agreement
10. Student account must be active for six months to be considered for the Student Account Scholarship.
11. All applications will be evaluated by the Scholarship Committee at PrimeWay Federal Credit Union.
12. Scholarship recipients agree to allow PrimeWay Federal Credit Union to publish this information and take photographs for credit union publications, offices and credit union-related trade publications.
13. Applicants may be asked to submit additional information and/or participate in a personal interview before a final decision is made.
